

**APPLICATION FOR LISTING PRODUCT FOR PUBLICATION  
WITH POLYUREA DEVELOPMENT ASSOCIATION**

The undersigned member of the Polyurea Development Association (PDA) hereby requests that the product listed below (Listed Product) be included for publication by the PDA, for a period of two (2) years, as a product meeting the definition of “pure polyurea” established by PDA, and in support of this request makes the following representations and covenants, to-wit:

- 1. Applicant.** The applicant is a member of the PDA in good standing.
- 2. Products.** That applicant currently manufactures the product listed below and identifies the product as “pure polyurea” through use of the PDA Product Logo.
- 3. Applicant’s Representations.** That the Listed Product or system fully meets and complies with the definition of polyurea as currently adopted and officially published by the PDA. In the event that the PDA shall amend its published definition at any time such that the Listed Product no longer meets the amended definition, applicant shall immediately notify PDA to remove the product from the published list.
- 4. Discontinuance of Manufacture.** That if applicant discontinues the manufacture of a Listed Product or changes the product such that it no longer complies with the PDA definition of “pure polyurea”, PDA will immediately be notified to remove the product from the PDA published list.
- 5. Non-Compliance Procedures.** Applicant understands that PDA has established a review process, including procedures for dealing with non-conformance of a Listed Product and Applicant agrees to comply with any testing and evaluation procedures as may be determined and announced by PDA or a sub-committee established to administer the review process. Such compliance may include payment of costs associated with administering product testing and review under the non-conformance procedures as well as such other actions as may be required by the PDA or its sub-committee.
- 6. Full Participation and Renewal Listing.** Applicant hereby agrees to abide by all provisions of this Product Listing Application and program, including all established procedures. Applicant understands and agrees that this Product Listing is for a period of two (2) years after which time a new application must be submitted for continued listing of any product.
- 7. Membership Benefit.** Applicant acknowledges that inclusion of the listed product is a courtesy extended to PDA members and that applicant has no absolute right or entitlement to such listing; that a condition for the listing is continued membership in PDA in good standing; and that applicant’s products shall immediately be removed from any published list of PDA in the event of termination of membership.
- 8. Hold Harmless.** Applicant covenants with PDA that all products submitted for listing will be in conformance with current PDA definitions of “pure polyurea” and hereby holds PDA harmless from any expenses, costs or damages resulting from claims, suits, judgments or any other cause related to a Listed Product.
- 9. Compliance with Changes.** Applicant hereby agrees to fully comply with all future changes or modifications of the rules and regulations regarding the listing of products, the non-compliance procedures or any other aspect of this Listing Program immediately upon notification of any such changes or modifications.
- 10. Applicant Covenant.** Applicant hereby covenants with PDA that all statements and representations in this application and request for product listing are true and correct.
